Appointment of Board Member: Motion by Mr. Cook – appoint Mr. David Johnson, Presiding Commissioner of Barton County, to the Region M Executive Board representing the County of Barton. Mr. Lance seconded the motion. All voted in favor. Motion carried.

Financial Update: Weston Rea, Accountant, presented financial reports to the board which included bank balances, FY2023 project balances, interest earned, and expenses for the month of February. Motion by Mr. Hawkins – accept and approve the financial report for the month ending February 28, 2023 as presented. Mr. Cook seconded the motion. All voted in favor. Motion carried.

Program Update: Patty Overman gave an update of tasks and activities since the last meeting. *FY2023* – The next quarterly reports are due on Friday, April 14, 2023 for the third quarter period ending March 31, 2023. Discussed recent tour at Noble Earth Recovery, the fencing being complete at Service Recycling, and the surge hopper installation at Ritter Industries.

Community Collection Events – Several electronics recycling and tire collection events have been scheduled for each county in the District for the next few months.

SWAB/DNR – There was no monthly meeting in March, the next one is scheduled for April 5, 2023. We received notification regarding the mileage rate increasing to \$0.62 per mile starting March 1, 2023. We received reports of the last two quarters of district allocations.

Financial Audit – NEO Accounting, PLLC, is working on this and should have the final report available for approval at our May meeting.

Other – the mobile app is taking more time than anticipated. The monthly newsletter analytics report is showing increased number of people opening it and clicking on links; pleased with the activity. MO PSC will give a brief presentation at our next meeting regarding HB880 and paint stewardship in Missouri. Overman recently passed along information about grants being available for foam recycling. There is little interest in this.

Grantee Requests: There were none.

FY2024 Update: There were 19 applications received with the total requested amount of \$860,739.57. Applicants will present their proposed projects during this meeting. The Review Committee will score the applications and projects based on criteria previously approved by the Executive Board. After scoresheets are turned in, projects will be placed in an aggregate ranking order and the Review Committee will meet with the intention of coming up with funding recommendations for the Executive Board to approve.

Momentarily break for lunch.

FY2024 Grantee Presentations: 17 of the 19 applicants were in attendance and each gave a brief presentation of their proposed projects. All 17 presentations were made at the front of the room and given adequate attention. Noble Earth Recovery did not have a representative available and a slide was shown with the project description, requested amount, and estimated tonnage diversion. The City of Sheldon did not have a representative available because of other engagements that day, but had previously requested to have read aloud and a slide be shown that included a summary, photo of collection vehicle and trailer, project description, funding requested, and estimation tonnage diversion.
