Executive Board Meeting Call to Order: Mr. Jamey Cope, Chairperson of the Region M Executive Board, called the meeting to order at 11:01 a.m.

Introductions: Chairperson Cope introduced himself and asked everyone to give their name and which organization they represent.

Approval of Agenda: Motion by Mr. Bartosh – approve and accept meeting agenda dated April 18, 2023, as presented. Mr. Worsley seconded the motion. All voted in favor. Motion carried.

Approval of Meeting Minutes: Motion by Mr. Worsley – approve and accept the meeting minutes dated March 21, 2023. Mr. Cook seconded the motion. All voted in favor. Motion carried.

Appointment of Board Member: Motion by Mr. Bartosh – appoint Mr. Nate Siler, Public Works Director for the City of Neosho, to the Region M Executive Board representing the Cities of Newton County. Mr. Worsley seconded the motion. All voted in favor. Motion carried.

Financial Update: In Weston Rea's absence, Patty Overman presented financial reports to the board which included bank balances, FY2023 project balances, interest earned, and expenses for the month of March. Motion by Mr. Bartosh – accept and approve the financial report for the month ending March 31, 2023 as presented. Mr. Cook seconded the motion. All voted in favor. Motion carried.

Program Update: Patty Overman gave an update of tasks and activities since the last meeting. *FY2023* – Reports have been received for the third quarter period ending March 31, 2023, with a total tonnage diversion of over 2900 tons.

Community Collection Events – Several electronics recycling and tire collection events have been scheduled for each county in the District for the next few months.

SWAB/DNR – Brief update on the lawsuit with District L and DNR, the potential formation of a formal group for the Districts to participate in, stakeholder meeting on June 6th regarding Landfill Operations, mileage rate increased to \$0.655 as of April 3, 2023, and the Annual Report being due soon, looking for volunteers for the committee.

Funding Opportunities – Overman mentioned the scrap tire grants through MDNR, composting grants through USDA, and the market development program through EIERA.

Legislation on Interest – HB93 requires a 1000' buffer zone for transfer stations. HB880 establishes a paint recycling program, requiring retailers and distributors to participate.

Industry Conferences – MWCC conference is in July and Overman will be attending one day. MORA Conference is in September, Patty is participating on the Awards Committee. Applied for funding to attend the Resource Recycling Conference in August.

Annual Management Council Meeting – Tuesday, August 15, 2023. Discussion of a commodities panel, appointment of Executive Board, Election of Officers, Review FY2023, goals for FY2024. Other – Overman will be attending the tour of Noble Hill Landfill in Springfield. Encouraged visiting some Earth Day events and showed several opportunities in the District for that day.

FY2024 Update: There were 19 applications received with the total requested amount of \$860,739.57. Target funding for projects is \$550,000.00. Funding approval is based on the review committee's scoresheets and aggregate ranking worksheet. Budget revisions are to be turned in by the end of the month. Final applications will be submitted to DNR in May. FAA's will be signed in June. July 1, 2023 is the tentative start date.

Kirra Antrobus, representative for the review committee, addressed the Board and others in attendance. Ms. Antrobus mentioned the review committee met the previous week and looked at different funding scenarios, but ultimately decided on recommending a percentage would be given based on the ranking order. She noted scores were based on the quality of the application.

Aggregate ranking and funding recommendations were presented for review.
