District L Lawsuit – Still under appeal.

Industry Conferences – Attended Resource Recycling in August in Orlando with funding provided through a grant from the Steve Thompson Memorial Fund.

Funding Opportunities – Several letters of support were written for the following applications: USDA, City of Neosho; Glass Recycling Foundation, Ritter Industries; Scrap Tire Surface Material Grants/DNR, Jasper School District, Carthage Parks and Recreation, Economic Security Early Head Start, and City of Joplin.
